Degree conferring a master's level qualification — RNCP : 35991

The CCA Master's degree is a high-level university program designed to train accounting and auditing professionals. The courses are taught in English by both academics and professionals, who are recognized specialists in their field. It combines theoretical knowledge with practical accounting and auditing skills, including legal and managerial concepts

Level of study

Master's degree (Bac +5); institution-awarded diploma at Level 7 (formerly Level I)

Credits

30 ECTS per semester, 120 ECTS in total

Admission Requirements

M1:

- ◆ CCA Bachelor's degree.
- ◆ Intec's DGC / State examination's DGC.
- ◆ General bachelor's degree in financial accounting, management accounting, or finance (Accounting and tax knowledge will be assessed).
- ◆ Possible access through VAPP (Validation of Professional and Personal Experience)
- + a minimum of TOEIC score of 760 is required or an average of more than 15/20 in English in Licence/Bachelor.

M2:

- ◆ Having passed the M1 (with an average grade of 10/20 in each semester and no UE grade below 6/20).

Program Duration

This program is completed over 2 years of study.

Training goals

Intec's CCA Master's training program is in line with the DSGC program, and all aspects of the program will be covered, in order to best prepare our students for the 2 UE of the DSGC required to enter the public accounting internship (UE 4: Accounting and auditing & UE 6: Finance). 16-week internship is required for students who are not part of an apprenticeship course or continuing education.

Graduation requirements

To obtain the **Master CCA 1st year** :

Successfully complete M1 (minimum average of 10/20 per semester, no grade below 6/20 in any course unit).

To obtain the **Master CCA 2nd year** :

Successfully complete all four semesters (minimum average of 10/20 per semester, no grade below 6/20 in any course unit.)

Important: semesters and academic years are not compensable. Only grades obtained in Intec-organized exams are considered, with possible bonus points from continuous assessment.
