

## Master CCA

### Alternating, English language courses, face-to-face

The master's degree—CCA—aims to give students both the theoretical skills linked to classroom learning and an operational knowledge of accounting and auditing practices and the related legal and managerial dimensions. During these two years of study, students acquire, in addition to their theoretical skills, the know-how, interpersonal skills and know-how necessary for professional development in positions of responsibility. During the two years of study, the students will spend three days a week in a firm or company and two days in training at Intec.

This formula of the CCA master's degree in alternation offers the students:

- course materials covering the entire programme (in paper and online versions);
- face-to-face courses in accordance with the content and time volumes of the DSCG, divided into two days per week, *i.e.* 14 hours of classes per week;
- webconferences—28 hours of interactive online revision sessions during the week—available off-line.

In this formula, it is not possible to repeat a year in M1. Apprentices are obliged to enrol *à la carte* in the non-validated M1 courses in order to move on to M2.

- Interview dates will vary according to the dates on which applications are received

Please note that in addition to the CV, letter of motivation and diploma, candidates can attach their results from the Score IAE message test and test TOEFL.

Candidates accepted into the Master CCA without having followed an accounting course may have to validate in M1 the UE 120 of in-depth accounting of the DGC of Intec.
